## **FOR CANADIAN RESIDENTS**

As we move closer to the tax filing deadline for personal income taxes, we would like to take this opportunity to outline the tax slips and reports in relation to your discretionary managed accounts with us. The actual slips you receive will depend on the types of accounts you have and the specific securities you own. #### **REGISTERED ACCOUNTS**

You will receive tax slips for contributions to an RRSP and for withdrawals from an RESP, RRSP, RRIF, LIF, LRIF and/or PRIF account. These slips will be sent to you by National Bank Independent Network (NBIN), the custodian of your accounts.
